It is understood that:

- (1) Entries for the Breed Survey must be made to the Breed Survey organizer at least seven days prior to the date of the Breed Survey.
- (2) copies of the original documents must be submitted with this entry.
- (3) original documents must be presented to the Breed Survey Secretary at check-in.
- (4) entries without the following original documents on the day of the Breed Survey will not be allowed to participate:

original AKC, SV or other FCI recognized club registration for all types of breed surveys. Must be from the dog's country of birth. Limited AKC registration is not acceptable.

original AKC, SV or other FCI recognized club 4-generation pedigree for all types of breed surveys with "a" or OFA hip certification, and "ED" elbow certification if born after January 1, 2004. Must be from the dog's country of birth. OFA Elbow certification is not acceptable. USCA Certificate of Pure Breeding is not acceptable.

original show card with at least a G rating by a SV Judge and from a class over 12 months of age for first time breed surveys and upgrades. Show ratings from the Open Class (24 month without title) and by USCA conformation judges are not acceptable.

original Körschein (if applicable) for the following Breed Survey Classes: 1) Breed Survey after interruption; 2) Lifetime/re-survey; 3) Upgrade.

original scorebook for first time breed surveys and upgrades (if not on SV pedigree papers) with AD, BH and at least one SchH or IP trial result earned under a SV or SV Foreign judge, GSDCA-WDA or USCA trial judge and passed with a score of at least 80 in the C phase, or an HGH. Dogs with a HGH title are not required to pass an AD or BH. (Note: if the working titles, BH and AD were not obtained under SV or SV Foreign judges, the Breed Survey may not be recognized outside of the U.S.).

original proof of AD if not recorded in scorebook or on SV pedigree papers.

original proof of change of ownership (signed letter from previous owner or Eigentümer, if applicable). Dogs owned or co-owned by a German resident are not permitted to participate in breed surveys in the United States.
